# WHERE ARE WE AT?

#### RNZRSA Constitution Draft at near final stage.

- Document to explain changes for consultation in development.
- Will clearly show the existing clauses and the changes to these.
- Three sections of change legally required; clarity and anomalies; improvements.
- Due to be posted on website Friday 5 July.



# WHERE ARE WE AT?

#### Model Constitution Draft at near final stage.

- Important RSAs have both documents to look at in context.
- Model Constitution is consistent with main constitution requirements.
- Helps RSAs get ready for re-registrations with the Incorporated Societies Act.
- Reminder final date for re-registration is 5 April 2026 17 months away.



## **OVER ARCHING CHANGES**

There are **three** over arching change reasons in the draft constitution:

- legally required
- clarity and anomalies
- improvement

# THE CONSTITUTION — WHAT TO EXPECT?

- The redrafted RNZRSA Constitution is adjusted to meet legislative requirements of the Incorporated Societies Act and to tidy up confusing language.
- In the main, most elements of the constitution remain the same.
- We are making the process as easy as possible for RSAs to update their model rules to align to the new constitution.



# THE CONSTITUTION — WHAT TO EXPECT?

#### Key things to note are:

- RSAs will stay as Incorporated Societies, and as members of the RNZRSA.
- The role of National President is solidified/clarified to legally meet the requirements of the Act.
- The RNZRSA Board and Forum will remain.
- The constitutional sections around Duties of an Officer will be made compliant with the new Act.
- The Disputes Resolution process will now sit mainly in the constitution to meet legal requirements.
- Same goes for Model Constitution.



# THE CONSTITUTION — WHAT TO EXPECT?

- Legally required example the National President on the Board.
- Improvement example Kaumatua on the Board.
- Clarity example tidy up provisions for online voting (taking out need for proxies).
- The Incorporated Societies Act provides multiple opportunities to give more clarity and fix anomalies eg:
  - The current Constitutions confuse a number of key points including:
    - i. Members of members.
    - i. National Conference, National Council, AGM.



# **CONSULTATION PLAN**
