This may take the form of support for health and wellbeing such as physiotherapy, counselling or financial support but may also be used for more practical purposes such as housing, vocational training or hardship alleviation.


## WHO DECIDES HOW THE BEQUEST IS USED?

Bequests to the RNZRSA are placed into the National Poppy Trust. The trustees of the National Poppy Trust are highly responsive and consider applications for support from veterans right across the country.

Our team consists of over 250 trained support advisors across the country and includes Veteran Employment Specialists. The RSA provides a wide range of support including expert advice and guidance, access to recovery and rehabilitation, improved access to medical and mental health support right through to support with the transition from military to civilian life and through-life employment support.
